## Vendor Rules

#### NO SATANIC PARAPHANALIA OR SYMBOLISM

### Fees:

Vendor fees are \$100 per stall.

## **Electricity:**

 Only certain stalls in the market have access to electricity. Please indicate on your application if you need access to electricity and we will do our best to accommodate you. If we are not able to put you in a stall with electricity, we will reach out to discuss your options.

## Parking:

 Parking is not available at your booth but within a 1-2 block proximity. You will be able to drive to your booth to unload and load before and after the event.

## Vendor Responsibility:

- Vendors are responsible for providing their own tents, tent weights, extension cords, lights, and any other necessary equipment and supplies.
- All vendor supplies must be contained within the vendor stall. NOTHING is to be outside, behind, next to the space or placed on sidewalks subsequently creating tripping hazards.

## **Setup Times:**

• You may begin setting up at 2:30 pm on October 4. Booths must be set up no later than 4:30pm, and in operation by 5:00pm. No vehicles are allowed within the District Frights event perimeter after this time.

## Vendor Rules

## **Hours:**

- District Frights will operate 5:00-9:00pm.
- All vendors must remain in place, booth intact, until the close of the festival at 9:00pm. If you sell out of items early, you may close your tent, but tables, tents, etc. may not be taken down until after 9:00pm.
- Vehicles cannot be pulled in to load until the area is opened to vehicle traffic.

#### Trash:

- There will be large garbage containers throughout the event. Volunteers will take care of removing full bags and replacing them with empty ones.
- Do not dump trash in any of the business' private dumpsters in the area.
- Vendor tent area must be free from trash before leaving the event.
- Any trash left on the sidewalks or in the area around your tent must be picked up.
- If the tent area is not properly cleaned, you may be charged an additional cleaning fee.

## **Propane Tank Use:**

• If using a propane tank, the tank must be secured. The smaller 20lb tanks can be in a milk crate secured with bungee cords, but larger tanks need to be secured with a chain, not bungee corded.

#### **Themed Products**

- A minimum of 50% of products in an event vendor's booth must be themed to the event.
- Examples: witches /wizards themed, magic, Halloween, mystic, fall/seasonal, natural healing.
- Vendors are encouraged to decorate per the theme of the festival to feel authentic and enhance the "spooky fun" atmosphere. Please remember this is a family-friendly event and there will be lots of children in attendance.

# Vendor Rules

## NO SATANIC PARAPHANALIA OR SYMBOLISM

#### Pets:

• No pets permitted within the festival area.

#### **Weather:**

- The event is rain or shine- please plan accordingly.
- If the event must be canceled due to severe weather, all vendors will receive a full refund.
- If you choose not to participate due to the weather and the event has not been officially cancelled, you will not receive a refund.
- No rain date is scheduled.
- All weather correspondence will occur via the email you applied to the market with.

## Refunds:

• Refunds are not issued except for applications that are not approved. If your application is not approved, you will receive a full refund to the card you originally paid with at the time of submitting your application.
