

**RELEASE OF LIABILITY AND WAIVER FOR MINOR PARTICIPANT
PLAYED WITH HEART, INC.**

This Release of Liability and Waiver (the "Agreement") is entered into by and between the parent/guardian listed on the registration form on behalf of the child listed on the registration form, (hereinafter referred to as the "Minor"), and **Played With Heart, Inc.**

In consideration of Minor being allowed to participate in golf lessons and related activities administered by Played with Heart, Inc., the undersigned, on behalf of myself and Minor, hereby acknowledges and agrees that:

1. ASSUMPTION OF RISK

I acknowledge and understand that golf lessons involve inherent risks, including but not limited to:

- Risk of injury from swinging clubs, golf balls, and other participants.
- Risks related to weather conditions, uneven terrain, and outdoor exposure.
- The possibility of minor or serious injury, including sprains, fractures, or other harm.

I, on behalf of myself and Minor, knowingly and freely assume all such risks, both known and unknown. I voluntarily allow Minor to participate in golf lessons and related activities, and I assume full responsibility for any risks, injuries, or damages, whether caused by negligence or otherwise.

I further understand and agree that **Played With Heart, Inc.** supplies all equipment "as is" and that **Played With Heart, Inc.** disclaims all warranties, express or implied, including warranties of merchantability and fitness for a particular purpose.

2. RELEASE OF LIABILITY

I, on behalf of myself and the Minor, hereby release, hold harmless and indemnify **Played With Heart, Inc.**, its offices, directors, employees, agents, volunteers, affiliates and, if applicable, owners and lessors of premises used by Played with Heart, Inc. ("Released Parties") from and against any present or future claims, demands, causes of action, suits, expenses, loss or liability for injury to person or property arising out of or related to the Minor's participation in golf lessons and related activities, whether arising from the negligence of Releasees or otherwise.

3. MEDICAL CONSENT

In the event of an emergency, I authorize the Released Parties to obtain medical treatment for the Minor, including transportation to a medical facility if necessary. I understand that I am responsible for all medical costs incurred.

4. MINOR'S UNDERSTANDING

I have explained to Minor the risks of this activity and his/her responsibility for adhering to the rules and regulations of Played with Heart, Inc.

5. PHOTO AND MEDIA RELEASE (Optional)

I grant permission for photographs and videos of the Minor participating in golf lessons to be used for promotional or educational purposes by **Played With Heart, Inc.**

6. ACKNOWLEDGMENT AND SIGNATURE

I have carefully read this Agreement and fully understand its contents. I am aware that by signing this document, I waive certain legal rights, and I sign it voluntarily.
