## **Short-Term Mission Trip Policies**

Thank you for your interest in attending a short-term mission trip with us! Before you complete your registration, please review and accept these important policies.

**Trip Fee.** I accept and agree to pay the stated fee for my short-term mission trip in accordance with the payment schedule and the fundraising policy. If I cannot fundraise enough money to cover the fee, I understand that it is my responsibility to timely pay the balance owed. I understand that my trip fee includes air tickets, overnight accommodations, meals, drinking water, transportation within the country of destination, translator fees if necessary, ministry expenses, basic tripinsurance, pre-trip training, trained and experienced One Plus God staff accompanying the team, and One Plus God merchandise. I understand that my trip fee does not include travel to and from the airport, meals at airports, fun day-off events, snacks, extra drinks or souvenirs.

**Required Training.** I agree to attend a required team or individual training session with One Plus God staff prior to departing on my selected mission trip.

General Conduct and Dress Code. I understand that during the time that I am traveling with One Plus God, I am expected to conduct myself in a manner that comports with the values expressed by One Plus God. I agree not to engage in any behavior that violates common standards of decency, fails to comply with community laws or statutes, or demonstrates contempt for the generally accepted values of One Plus God. I agree not to wear clothing that is revealing (ie., short- shorts, clothing that exposes the stomach, back, or undergarments) or clothing that displays any suggestive or objectionable material.

**Tobacco/Alcohol Use**. I agree not to use, possess or be under the influence of alcohol or illegal drugs at any time during the mission trip, including at the airports. I understand that the use of nicotine products, including cigarettes, may be prohibited in some places and I agree to abide by the local rules, customs and requests of local authorities, One Plus God and others that I come in contact with on the mission trip.

**Photo Release.** I agree that One Plus God Ministries, Inc., its employees, representatives and agents may take photographs and/or videos of me in connection with the short-term mission trip that I have selected. I further authorize One Plus God Ministries, Inc., its assigns and transferees to copyright, use and publish the same in print and/or electronically. I agree that One Plus God Ministries, Inc. may edit the photographs and/or videos as it deems necessary and may use such photographs and/orvideos for any lawful purposes, with or without my name and with or without further notice to or consent from me, including for example such purposes as publicity, illustration, advertising and Webcontent.

**Basic Insurance. Your registration for a One Plus God trip includes insurance** coverage **provided by Insurance Services of America.** While traveling with One Plus God, this insurance may provide up to \$1,000,000 in international major medical protection; up to \$1,000,000 in emergency medical evacuation costs; up to \$1,000,000 for an acute onset of a pre-existing condition; 100% U&C coverage outside the US; coverage for events of Terrorism, political evacuation, emergency reunion, AD&D and repatriation; Trip interruption, lost checked luggage benefit, lost passport assistance, and emergency dental care.

I understand and agree that my personal health insurance information will need to be provided to the OPG staff and that my personal health insurance may be treated as the primary insurance source before the secondary insurance with Insurance Services of America applies.

In the event that One Plus God advances funds for my care during my trip that are later reimbursed to me by any insurance company, I agree to reimburse One Plus God within 14 days of my receipt of payment.

**Waiver and Release.** By virtue of participating in the above-described mission trip and any activity directly or indirectly related thereto, and in consideration of being permitted to participate in said mission trip, and forother good and valuable consideration, the receipt and sufficiency of which is acknowledged, I, individually and on behalf of my heirs, executors, administrators, and assigns, fully release and discharge One Plus God Ministries, Inc., (OPG) from any and all rights, claims and actions that I now have or may have in the future gainst OPG, all with the knowledge that OPG will rely on the same.

I am an adult (or if I am a minor, the parent/guardian signing this Release on behalf of me is an adult) and I am not under any disability impacting my ability to read and understand the terms of this Release. I have read this Release and understand its terms. I freely and voluntarily execute this Release. In executing this Release, I do not rely on any inducements, promises, or representations made by OPG, the above- described representatives, or any other party connected with OPG.

I fully comprehend and accept all of the risks associated with my participation in an international mission tripincluding, without limitation, risks of travel, exposure to unfavorable weather conditions, civil unrest, food sickness, pathogens and disease associated with undeveloped and underdeveloped nations, property loss or damage, and the potential for acts of terrorism, kidnapping, injuries and/or death.

I am in good health and suffer from no minor or serious physical or mental injury, illness or disability that would make me susceptible to injury or disability while participating in themission trip or performing any activity contemplated by this Waiver and Release of Claims.

I, individually and on behalf of any person or entity acting through or on behalf of me, hereby forever and unconditionally release OPG and any affiliated entities, parent companies, subsidiaries, present and former employees, owners, officers, members, managers, partners, contractors, agents, insurers, shareholders and directors of OPG (collectively, OPG) from any and all claims, actions, damages, liabilities, losses, costs and expenses in any way arising out of or imitation, any and all claims, actions and liabilities for death, injury, loss or damage to me, to anyone else or to any property, regardless of whether or not such death, injury, loss or damage resulted from the negligence of OPG or any other person. I, individually and on behalf of any person or entity acting through or on behalf of me, further agree to defend and indemnify OPG from any and all liabilities, claims, actions, damages, expenses (including without limitation, attorney's fees) and losses of any kind or nature whatsoever in any way arising out of, or resulting from my participation in the mission trip.

This Waiver and Release of Claims constitutes the entire agreement and understanding between me and OPG and cancels, terminates and supersedes any prior agreement or understanding relating to the subject matter hereof. There are no representations, promises, agreements, warranties, covenants, or undertakings other than those contained in this Waiver and Release of Claims.

None of the provisions of this Waiver and Release of Claims can be waived or modified except expressly in writing signed by OPG and me. Failure of OPG to enforce any of their rights hereunder at any time shall not act as a waiver to enforce their rights under this Waiver and Release for same or similar acts at any subsequent time.
