

Summer Camps Release

- 1. In consideration for participating in the Zeeland Christian Summer Camps, the parent(s) and/or legal guardian(s) of the minor participant named below (hereinafter referred to as PARTICIPANT) agree hereby release, waive, discharge and covenant not to sue Zeeland Christian Schools, the Board of Directors, their officers, agents, and employees (hereinafter referred to as RELEASEES) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by PARTICIPANT, or to any property belonging to PARTICIPANT or me, whether caused by the negligence of the RELEASEES, or otherwise, while participating in such activity, or while in, on or upon the premises where the activity is being conducted or in transportation to and from said premises.
- 2. To the best of my knowledge, PARTICIPANT can fully participate in this activity. I am fully aware of risks and hazards connected with the activity, including but not limited to the risks as noted herein, and I hereby elect to allow PARTICIPATE to voluntarily participate in said activity, and to enter the above-named premises and engage in such activity knowing that the activity may be hazardous to PARTICIPANT and PARTICIPANT'S or my property. I voluntarily assume full responsibility for any risks of Loss, property or personal injury, including death of PARTICIPANT, that may be sustained by PARTICIPANT, or any loss or damage to property owned by PARTICIPANT or me, as a result of being engaged in such an activity, whether caused by the negligence of RELEASEES or otherwise.
- 3. I further hereby agree to indemnify and hold harmless the RELEASEES from any loss, liability, damage or costs, including court costs and attorney's fees, that may incur due to PARTICIPANT'S participation in said activity, whether caused by negligence of RELEASEES or otherwise.
- 4. It is my express intent that this Release and Hold Harmless Agreement shall bind the members of PARTICIPANT'S family, assigns and personal representative, shall be deemed as a release, waiver, discharge and covenant no to sue the above named RELEASEES. I hereby

further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the State of Michigan.

- 5. I understand that the school will not be responsible for any medical costs associated with an injury PARTICIPANT may sustain.
- 6. I further agree to become familiar with the rules and regulations of Zeeland Christian School concerning student conduct and to convey to PARTICIPANT not to violate said rules of any directive or instruction made by the person or persons in charge of said activity and that PARTICIPANT will further assume the complete risk of any activity done in violation of any rule or directive or instruction.
- 7. I also understand that PARTICIPANT should and is urged by Zeeland Christian School to obtain adequate health and accident insurance to cover any personal injury to PARTICIPANT which may be sustained during the activity or the transportation to and from said activity.
- 8. I also understand that PARTICIPANT is responsible for any damage PARTICIPANT causes to the facilities. In signing this release, I acknowledge and represent that I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements or inducements, apart from the foregoing written agreement, have been made; I am fully competent; and I execute this Release for full, adequate and complete consideration fully intending to be bound by same.
- 9. I grant Zeeland Christian School, its representatives and employees the right to use PARTICIPANT'S images (photos, digital, video), sound recordings of PARTICIPANT'S voice, and any materials generated during participation in Zeeland Christian School events.
- 10. I have established a plan for picking up PARTICIPANT from the conclusion of the program each day.

WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT I hereby give my permission, consent and authorization for any medical treatment deemed necessary by a hospital or physician. I appoint the event coordinator and/or director my lawful agent with power to authorize and consent to the administration of medical treatment during the event.

In case of such accident or illness, I give permission for medical treatment to be given to PARTICIPANT as deemed appropriate. I will assume responsibility for any medical treatment as deemed appropriate. I will assume responsibility for any medical bills incurred on PARTICIPANT'S behalf.
