Tour Information & Conditions

HEALTH & SAFETY NOTICE

Hope Channel cares about your health and safety and is closely monitoring recommendations given by the CDC and international local authorities related to COVID-19. Please be aware that protocols may include mandatory face masks, proof of a negative test or vaccination, and certain social distancing. Continued monitoring of official guidelines will inform tour protocols. Individuals with higher risk factors may want to consider attending a future tour when conditions may have improved.

TOUR INFORMATION

Accommodations: Five-star hotels have been selected for this tour. Pricing is per person and based on double occupancy. For single occupancy private rooms, a surcharge has been added.

Audio Receivers: Audio receivers and earbuds will be provided by the guide for each participant. Participants should take responsibility for returning the audio receivers in good condition.

Coach Transportation: All tour ground transportation will be via air-conditioned deluxe motor coach with space for 49 individuals.

Insurance: Short-term travel insurance from Adventist Risk Management is included in the tour cost to mitigate injury or trip interruption during the tour. Please review the details of the Adventist Risk Management coverage at the end of this document. Note that coverage is not available for those over 85 years of age.

Participants are responsible for purchasing any additional health or travel insurance that they desire. Airline ticket insurance for ticket cancellations under approved circumstances is recommended. Please contact your travel agent or credit card company for information or purchase the additional protection when purchasing your airline tickets.

NOTE: Hope Channel International cannot be held responsible for personal injury, loss or theft of passenger's baggage, for any disruption or cancellation of advertised schedules, for corporate travel restrictions, for acts of God, disease, pandemics, war, threats or acts of terrorism or similar acts, disasters of any kind, strikes or the imminent threat thereof, financial collapse, government regulation, State Department or other governmental or international agency travel advisory, civil disorder or disturbance, curtailment or interruption of transportation facilities, or any other emergency beyond their control.

Itinerary Changes: The daily itinerary may be adapted due to unknown closures, or unforeseen circumstances. Hope Channel International reserves the right to make any itinerary adjustments necessary for any reason.

Luggage: The coach has limited storage; each person is allowed a maximum of **one** suitcase not to exceed what the airlines allow in size or weight. A handbag and small camera case are also allowed on the coach. Participants should be prepared to carry their own luggage; baggage handling is limited in some locations.

Meals: Vegetarian meals will be provided. Please indicate specific dietary preferences during registration.

No Smoking/Drugs/Alcohol Policy: No smoking, drugs, or use of alcoholic beverages is permitted.

NOT Included: International airfare, ticket insurance, passports, visas, and laundry are not included. Drinks ordered at mealtimes are also not included. Each person must pay for their beverages.

Passports and Visas: Participants are responsible for securing their own passports and visas for international travel.

Participants must have current passports valid for at least six months beyond the end of the tour with multiple blank pages available. Persons with US passports do not need a special visa before entering Israel, however, it is advised that you request

an entry stamp on a separate paper kept in your passport, rather than have them stamp your passport. This will facilitate future travel to other Middle Eastern countries.

Persons of non-US nationalities may contact the General Conference Visa Office for advice and assistance. If visa applications are necessary, an \$85 service fee will be added to the application costs and will be payable directly to the General Conference Visa Office. Please visit their website for more information.

NOTE: Hope Channel International cannot be held responsible for those who fail to obtain proper travel documents in a timely manner. Hope Channel International cannot refund persons whose visas do not arrive on time.

Payment & Cancellations Schedule: The payment schedule is as follows:

- A deposit of \$200 per person is due upon registration
- Interim payments are permitted at your convenience
- The balance of the full payment is due by January 26, 2023. Credit card payments will be processed <u>automatically</u> on that date.

Cancellation notices must be submitted in writing to: events@hopetv.org. It is strongly recommended that participants purchase their own ticket insurance when purchasing airline tickets to protect in case of emergencies or valid cancellations. Tour cancellation terms are as follows:

- Cancellations by December 26, 2022, will receive a refund, less a \$20 administrative fee.
- Cancellations after December 26, 2022, will receive a refund, less paid deposit.
- Cancellations after January 26, 2023, will receive a refund, less 25% of the cost of the tour.
- Cancellations after February 26, 2023, will receive a refund, less 50% of the cost of the tour.
- Cancellations after March 26, 2023, will not receive a refund.

Refunds will be made available if Hope Channel must cancel the tour due to unexpected situations, such as security or health concerns, etc.
